Pop-Up Craft Fair Guidelines

Artist Responsibilities:

- All work must be handcrafted, current work produced by the artist.
- Artists are responsible for processing their own sales.
- Artists are responsible for all setup and break-down related to their booths.
- Artists may not share booths, with the exception of TACS' Studio Committees conducting fundraisers.
- Artists or a designated representative must be present during the entire fair on both Friday and Saturday.
- The \$25 booth fee is non-refundable.

Booth Assignment:

- Booths will be assigned on a first-come-first-served basis.
- Booth assignments are at the sole discretion of TACS and are not interchangeable.
- Booth locations will be communicated the week of the event.

Advertising and Promotion:

TACS' advertising and publicity campaign will be promoted throughout the region. The fair will be marketed through social media, TACS' website, eblasts, tourist publications, Tryon Daily Bulletin, and printed fliers.

Fair Unloading:

9:00 to 11:30 am, Friday, August 2

Artists may pull into TACS' front parking lot, directly in front of their booths to unload.

Parking:

After unloading, artists should park in TACS' rear parking lot, accessible by turning off of Harmon Field Road at the tennis courts. Artists may not park in the front parking lot, grass, or neighboring properties not belonging to TACS.

Artist Load Out:

1:00 to 2:00 pm, Saturday, August 3

Artists must remove all belongings from the space and fully clean the area around their display. Trash bins are located in TACS' rear parking lot, accessible by turning off of Harmon Field Road at the tennis courts. Recycling containers are located in TACS' kitchen.
